CARIBBEAN SOCCER EXTRAVAGANZA ROUND ROBIN TOURNAMENT 2020 RULES AND REGULATIONS

STARTING TIME:

The Tournament shall begin at 9:00 a.m., Saturday, August 8, 2020. Teams involved in the first game must report through their manager or captain to the officials table 10 minutes before starting time. Failure to do so will result in forfeiture for the non-reporting team, with the reporting team declared the winner.

For subsequent games the team must report in the same manner, five (5) minute before the end of the game in progress. Announcements will be made at the field so teams will be aware of the time and teams to play the next game.

TROPHIES AND MEMENTOS:

The winners of the open tournament shall be awarded a team trophy and seventeen (17) mementos. The runner-up shall receive a team trophy. The winners of the over 45 division shall be awarded a team trophy and seventeen (17) mementos. The runner-up shall receive a team trophy.

Trophies shall be awarded to the most outstanding player, and to the most disciplined team. The round robin committee or its designer may seek comments from the game officials in reaching its decision.

TEAMS AND MEMBERS:

Each team is allowed seventeen (17) members, whose names must be submitted fifteen (15) minutes before 9:00 a.m., August 8, 2020.

Each team will wear its own distinctive colors but is required to provide a set of "white" so as to resolve any confusion similarity of colors, in such a case the team to wear "white" will be decided by coin flip, except that where a local team is involved with a visiting team the local team will wear "white".

FIELD AND OFFICIALS:

Teams are required to keep their members off the field (except when they are involved in the match in progress) and away from the sidelines. All supporters are to remain in the stands, (Bleachers/Grandstands).

Officials will be assigned to matches by the tournament committee. These officials will carry the official time on the field. Only Team Captains will discuss disputed matters with the officials.

FORMAT MATCHES AND RESULTS:

There will be two (2) divisions of four (4) teams. Each preliminary game will last twenty (30) minutes. The winners of each division will advance to the final. The final game will last Thirty (30) minutes (time permitting).

In the over 40 division there will be two (2) divisions of four (4) teams. The winners of each division will play the final.

Three points will be awarded to the winner of a game in regulation time. Two (2) points will be awarded to the winner for a forfeit (no-goals). One (1) point will be awarded for a tie game.

A tie for the division lead will be resolved as follows:

- Most Goals for----wins
- Least goals against ---- wins
- The team who has won the head to head ----- wins
- Sudden death penalty kicks.

Judging for the Most Outstanding Awards will occur only during the preliminary games. The award for the Most Disciplined team will be based on conduct throughout the entire tournament.

In the over 45 (Masters Division), each player must be 45 or over - **no exceptions**. Any team found in violation will forfeit the game in question.

In the event of a protest involving one's age, the burden of proof rest with the offending team. Proper ID is needed.

In the spirit of fair and keen competition, it is anticipated that there will be no frivolous application of this rule.

A protest is valid only when it is called before or during the course Of the game in question.

All protests must be resolved before the accused team plays another game.

Applications are due by June 1, 2020 Any team missing this registration deadline will be assessed a \$25.00 late fee.

The Tournament will be held at Lake Clifton Park located at the 2800 block of Harford Rd. & **2801 Saint Lo Drive**. Baltimore, Maryland on August 8, 2020. Time will be 9:00 a.m. sharp.

TO SOCCER FIELD FROM NY, NJ & PHILADELPHIA:

Take NJ Turnpike to 95 South, Baltimore, follow exit 65-895 to Harbor Tunnel Annapolis Baybridge, take exit I4 marked Moravia Road bare right onto Moravia. Moravia Rd. changes to Cold Spring Lane make left onto Harford road and then left onto 2801 Saint Lo Drive at the **2800 block of Harford Rd**. (Lake Clifton Park)

TO SOCCER FIELD FROM BALTIMORE WASHINGTON PARKWAY: Take BW Parkway, downtown Baltimore exit make right on Pratt Street & left onto Gay St. which changes to Harford Rd. Go to the **2800 block of Harford Rd**. at 2801 Saint Lo Drive make right. (Lake Clifton Park)

TO SOCCER FIELD FROM WASHINGTON 95 NORTH:

Take 95 North through Fort McHenry Tunnel. Take Exit 60 Moravia Road changes to Cold Spring Lane and make left on Harford Rd, travel south on Harford Rd. then make left on 2801 Saint Lo Drive at the **2800 block of Harford Rd**.
